EDUCATIONAL GOALS AND EXPECTED LEARNING OUTCOMES

The course of forestry legislation, after an introduction on the founding principles, history and sources of forestenvironmental law, intends to deal with an applicative approach the main laws and regulations on forestry resources, with which relate on national and regional territory.

- * Knowledge and understanding: teaching provides the students with the theoretical and practical tools to understand the policies (regional, national and international) related to agro-forestry and environmental sector, as well as the skills needed to undertake the next courses in the Master's Degree course.
- Applying knowledge and understanding: the aim of the course is to provide the student with knowledge and understanding of laws and regulations that must be applied by technicians and professionals in the forestry and environmental field. In particular, the student will be able to acquire competences to interpret the main issues of environmental and climate policy, with particular reference to the connections with forestry sector.
- ❖ Making judgements: develop the ability to understand policies useful to determine autonomous judgments, including reflection on related science themes.
- **Communication skills**: develop the ability to communicate information, ideas, problems and solutions to specialist and non-specialist stakeholders.
- Learning skills: develop learning skills that are required to undertake subsequent studies with a high degree of autonomy

SYLLABUS

Lessons I (1 ETCS, 8 hour)

General aspects, principles and sources of law; historical notes on forestry legislation; the Serpieri Law n.3267 of 1923; the geological and forestry constraints.

Lessons II (1 ETCS, 8 hour)

The transfer of skills in the forestry sector by the state to the regions; the evolution of landscape regulations.

Lessons III (1 ETCS, 8 hour)

Legislative Decree no. 227 of 2001 "Orientation and modernization of the forestry sector"; Principles and first definition of forest; forestry and environmental development; sustainable forest management.

Lessons IV (1 ETCS, 8 hour)

The national and regional forest plan; the forest cuts; control of forest cuts and outlines on irregularities and administrative sanctions.

Lessons V (1 ETCS, 8 hour)

The international trade of animal and plant species endangered (CITES); illegally sourced wood international trade; the FLEGT Regulation, the EUTR Regulation; Law no. 394 of 1991 "law on protected areas"; the Natura 2000 network in the field of biodiversity conservation; Law no. 353 2000 "Law on forest fires'; Law no. 10 of 2013, "Protection and preservation of monumental trees".



Lessons VI (1 ETCS, 16 hour)

Practice in the woods; execution control of a Forest harvesting intervention

TEACHING METHODS

40 hours of lessons 16 hours of laboratory.

Oral examination at the end of the course.
